A. TAIWAN: In-Country Program Fees Vary- Applicants will pay in-country program fees based on the program they adopt from. The fees are determined by Gladney's in-country partner agencies.

Cathwel Program Fees:

1. \$10,000 for the adoption of a child six years of age or younger at the time of referral that Cathwel has NOT identified as a "special needs" adoption case.
2. \$6,000 for the adoption of a child over six years of age at the time of referral or a child of any age that Cathwel has identified as a "special needs" adoption case.
3. Sibling groups: an additional fee of \$6,000 per child is due at time of dossier submission (reduced to \$4,000 if the child is over six years of age or identified as a "special needs" adoption case).

Chung Yi Program Fees:

1. \$11,000 for the adoption of a child five years of age or younger at the time of referral that Chung Yi has NOT identified as a "special needs" adoption.
2. \$7,000 for the adoption of a child over five years of age at the time of referral or a child of any age that Chung Yi has identified as a "special needs" adoption case.
3. Sibling groups: an additional fee of \$11,000 per child is due at time of dossier submission (reduced to \$7,000 if the child is over five years of age or identified as a "special needs" adoption case).
4. A \$2,200 non-refundable portion of the total Chung Yi Program Fees is due with the submission of a preliminary package to Chung Yi.

B. Concurrent Applications— Applicants may start their adoption process with concurrent applications in the China and the Taiwan programs. Fees for concurrent applications are adjusted as follows:

1. The Gladney Application Fee of \$600 will be charged once and apply to both programs.
2. The Gladney Home Study Fee will be \$3,500 and charged once. Two separate home study reports will be issued. \$1,750 will be due at application and \$1,750 will be due at the time the two reports are finalized.
3. Installment #1 and #2 of the Gladney Program Fees will be charged once and apply to both programs. Installment #3 is applicable under both program fee schedules depending on the continuation of the Prospective Adoptive Parents in one or both programs. Installment #4 will only become due once at referral acceptance.
4. All other fees indicated in the FINANCIAL AGREEMENTS for China and Taiwan will apply at the amounts and times indicated. Once a child referral from one country is accepted, the process in the other country will be placed on hold or the file closed. At least one year of time must pass after completing the first adoption prior to a family pursuing a subsequent adoption.

C. 2nd (or subsequent) adoption from Asia through Gladney's program- Gladney Parents who have completed one adoption from Taiwan or China and apply to begin a second adoption from the same country within 5 years of their prior adoption will have the Application Fee applied at 50% and Installment #1 of the Gladney Program Fee reduced by \$500.

D. Fees are best estimates and subject to change- We have been advised of, and agree to pay, the above fees in regard to our adoption with the Gladney Center. We understand that some fees are estimates and subject to change. Fluctuations of the US dollar against the New Taiwan Dollar (TWD) may result in increased or decreased *International Fees*.
